➤ **Important deadlines are as follows:**

20-Feb-2017 – Deadline for the submission of proposals for special sessions (academic & professional), workshops, seminars, panel discussions, position papers, special issues of journals and other related activities.

30-May-2017 – Deadline for the submission of peer-reviewed abstracts (to be included in ISBN-ed proceedings, planned to be indexed in major indices).

30-Jun-2017 – Deadline for full paper submission (of peer-reviewed papers).

15-Jul-2017 – Deadline for professional presentations.

31-Jul-2017 – Deadline for paper ready-paper.



➤ Paper publication

Peer-reviewing process Submitted papers will be peer-reviewed by at least three scholars on the basis of technical quality, relevance, originality, significance and clarity. Papers, achieved the highest scores with peer reviewers, will be suggested to expand and will be printed published as a book.

IPMA WC2017 proceedings will be produced with all accepted papers. The reported papers will be submitted for inclusion in the IEEE Xplore digital library, well as other Abstracting and Indexing (A&I) databases (Web of Science, Scopus, Google Scholar and etc).

Articles submitted for consideration by the program committee should fully comply with the requirements for registration; otherwise the manuscript will not be published.

Payment for the publication of conference materials is included in the conference fee.

➤ Requirements for preparing of papers

A paper should be written in English.

A paper of 5 full pages is requested.

Use a regular **Times New Roman** font, at **14pt** throughout your paper and single line spacing with one character space between sentences, indentations and UDC; a paper should contain a name (up to 10 words), keywords (up to 10 words), names of the authors, abstract, Extended abstract (100-250 words), literature review, 20 mm margins. Illustrations should be sent in JPG.
