

APPLICATION AND REGISTRATION PROCESS

The registration process begins by submitting the application form via my.ipma.world. Your application documentation is assessed by two independent REG Assessors operating within the national IPMA Member Association. Courses/programmes accepted by REG Assessors receive IPMA confirmation and providers the status of IPMA REG Partners.
